Boatman, 2nd by S. Milligan to have Beffa and S. Milligan as the electors to canvas the vote for each office.

Parkos asked again if there were nominations for any other electors to canvas the vote for each office. No reply. Beffa and S. Milligan will act as electors to canvas vote for each office.

Parkos called for nominations for the 2 -year term of Village President. L. Zillmer nominated Mark Manning.

Parkos asked for a second. No second.

Boatman nominated R. VanGilder for Village President. 2nd by P. Parkos. Parkos asked 3 times if there were any other nominations for Village President. No response. Nominations for Village President were closed.

Parkos asked for nominations for the 2 positions of Village Trustee. L. Zillmer nominated Mark Manning.

Parkos asked for a second. No second.

Boatman nominated Randy Seffinga for the position of Village Trustee. 2nd by P. Parkos.

Parkos nominated Brett Boatman for the position of Village Trustee. 2nd by S. Milligan.

Parkos then asked 3 times if there were any other nominations for the position of Village Trustee. There was no response. Motion by Boatman, 2nd by S. Milligan to close nominations for Village Trustee.

Motion by Boatman, 2nd by Parkos to adjourn.
